Entries must be submitted by each head coach on Mile Split <u>NO LATER THAN</u> <u>11:59 P.M. ON Sat., MAY 14.</u> IF YOU DO YOUR ENTRY EARLIER, PLEASE DO YOUR INVOICE EARLIER. DO NOT WAIT! After completing your entry, print out an "invoice" for your school. The Mile Split program will allow you to do this. If you have any questions on this process Brendan Donegan 201-230-0682. The only issue will be that the invoice you obtain from Mile Split will not separate the cost for your boys' team and girls' team. If your school has separate head coaches for boys and girls, the coaches will have to compare notes --- if your A.D. or Business Office needs that info to cut their checks.

HIGH JUMP

Coaches & Athletes:

Any competitor **leaving** the High Jump event to compete in **another event** must first check in with the High Jump official.

When all the remaining **excused** competitors have exhausted their trials at that height, the official will inform the announcer that excused competitors have **FIVE MINUTES** until the bar is raised to the next height.

If the **excused competitors** fail to return within the five (5) minute period, they must take their remaining trials at the **HIGHER HEIGHT**.

LONG JUMP, TRIPLE JUMP. POLE VAULT, JAVELIN

RUN BACKS WILL NOT BE PERMITTED ON THE RUNWAY TO DETERMINE A COMPETITOR'S APPROACH. ALL APPROACH DETERMINATIONS MUST BE IN THE DIRECTION OF THE PIT/FOUL LINE

From 287 North:

Take Exit 44 (Main St./Boonton). Make a sharp left at end of ramp onto Lathrop Avenue. Pass Boonton HS and several homes on the left. Turn left into entrance to high school parking lot behind the school.

Bus:

From 287 North take exit 45 / Wootton St. At end of ramp continue to the first stop sign and turn right onto Wootton St. Go to T-stop and turn right onto Lathrop Ave. Pass John Hill School on your left and take your first right into the parking lot in the back of Boonton High School.

From 287 South: (Bus & Cars)

Take Myrtle Ave. exit. Turn left at end of ramp onto Myrtle Ave. At 2nd traffic light turn left onto Wootton street. Continue on until the road T-stops onto Lathrop Avenue. Turn right. Pass John Hill School on your left. Take next right into entrance to Boonton HS parking lot behind the school.

From 46 East :

Take the exit for Passaic, Fairfield and Lincoln Park. Take a Left and go over Rt. 46. Go to the stop sign and turn left onto Two Bridges Rd. Go to stop sign. Bear Left onto Pine Brook Rd. Go about 1 mile up the hill and turn left onto West Pine Brook Rd. Go about 1 mile passing a Convalescent Home on the left. Take the 2nd Deer Run entrance to the Golf Course.

From 46 West:

Take the exit for Passaic, Fairfield and Lincoln Park. Bear right at the end of the ramp onto Passaic Avenue. Go to the stop sign and turn left onto Two Bridges Rd. Go to stop sign. Bear Left onto Pine Brook Rd. Go about 1 mile up the hill and turn left onto West Pine Brook Rd. Go about 1 mile passing a Convalescent Home on the left. Take the 2nd Deer Run entrance to the Golf Course.
