## Meet info:

Our track is a $\mathbf{2 0 0}$ Meter poured polyurethane surface with $\mathbf{6}$ sprint lanes \& 5 lanes on the oval. It is a soft surface, therefore, No hard plastic/metal running spikes or inserts may be used on the surface. Green vinyl tape will be provided at each field event station for jumping and relay marks. Locker rooms are available; athletes should bring a lock. Concessions will be available in the commons area during the meet. Trainer coverage provided.

## Entries:

A school may enter a maximum of:

1. 3 Varsity \& 2 JV entries in the running and field events.
2. Relays -1 Varsity \& 1 JV team in each relay.
3. An athlete may only enter a maximum of four events, but they may not be in no more than three running or three field events. (Being listed as a substitute on a relay team counts as an event.)
